



## Introduction

1. The “**AIA Vitality Team-Up Circuit Challenge (By Fitness First)**” (“**Event**”) is a fitness challenge hosted and organized by Fitness First Singapore Pte. Ltd. (“**Fitness First**”), AIA Singapore Private Limited’s (“**AIA**”) appointed event organizer.
2. The Challenge will take place on 16 July 2022, 0900-1100 hours (“**Event Period**”) at Fitness First, Bugis located at 200 Victoria Street, #04-02, Bugis Junction, Singapore 188021 (“**Event Location**”).
3. The Challenge shall be governed by the terms and conditions set out herein (“**T&Cs**”) and by such terms as AIA and Fitness First may impose from time to time. Your participation in the Event signifies your agreement to be bound by the foregoing terms and conditions in their entirety.

## Event Details and Eligibility

4. Participation in the Event is open to all individuals who are Singaporeans and residents in Singapore aged 18 years and above during the Event Period. Any individual who registers for or participates in the Event shall hereinafter be referred to as a participant (“**Participant**”).
5. Registration for the Event will commence on 1 July 2022 at 0000 hours (Singapore time) and end on 10 July 2022 at 2359 hours (Singapore time) (“**Registration Period**”), and take place on AIA’s website: [www.tinyurl.com/TeamChallengeRegistration](http://www.tinyurl.com/TeamChallengeRegistration) (“**Registration Form**”).
6. Registration for the Event will be accepted only during the Registration Period. No registrations for the Event will be accepted after 10 July 2022, 2359 hours (Singapore time).
7. To participate in the Event, Participants must do all of the following:
  - (a) Form a team of 8 Participants with at least 4 AIA Vitality members in the team and appoint a Team Leader from within the team. **Teams of less than 8 Participants will not qualify.**
  - (b) Provide the Team Leader with the relevant personal data related consents and appoint the Team Leader to fill in the relevant form and make a nominal payment of S\$80 to Fitness First (for 8 team members at S\$10 each) for organizing the Event (“**Nominal Payment**”) at Fitness First’s website: [www.tinyurl.com/TeamChallengePayment](http://www.tinyurl.com/TeamChallengePayment). Team Leader to indicate Team Name within the “First Name” field when duly completing the form and making payment on Fitness First’s page.
  - (c) Provide the Team Leader with the relevant personal data related consents and appoint the Team Leader to submit the duly completed Registration Form within the Registration Period.
  - (d) Turn up for the Event and participate in the Event’s activities per Fitness First’s instructions.
8. If Participant is an AIA Vitality member and wishes to be awarded AIA Vitality points and/or Vitality coins (where applicable) for their participation in the Event into AIA Vitality membership account, the Participant must input his/her AIA Vitality membership number accurately when registering for the Event.
9. Only AIA Vitality members who have provided a valid AIA Vitality membership number at the point of registration and awarding of points/coins will be eligible to earn the AIA Vitality points and Vitality coins (where applicable).



10. AIA Vitality members who participate in the Event and clock their activity with supported fitness devices/apps linked to MyAIASG app will continue to earn physical activity points for their Weekly Fitness Challenge.
11. Applicable data, phone, Internet, postal or any other charges may apply in relation to the Participant's registration for and participation in the Event, and each Participant shall be responsible for their own such costs and expenses.

## Prizes and Winners List

12. The results for the Event will be announced live at the Event Location at the end of the Event.
13. There will be 3 winners selected: (i) Champion Team – the team with the highest number of points from the Event; (ii) First Runner-up Team – the team with the second highest number of points from the Event; and (iii) Second Runner-up Team – the team with the third highest number of points from the Event. The Participant(s) may earn points by participating in the Event's activities.
14. Participants from the winning teams will each receive a Fitness First Completion Pack (comprising of 1x Fitness First MyCoach Assessment, 1x 14-day Fitness First membership, and 1x limited edition Fitness First corporate backpack). Participants from the winning teams who are AIA Vitality members will also receive Vitality coins: (i) Champion Team – 2,000 Vitality coins per AIA Vitality member; (ii) First Runner-up Team – 1,000 Vitality coins per AIA Vitality member; and (iii) Second Runner-up Team – 500 Vitality coins per AIA Vitality member.
15. AIA Vitality members will be notified when the AIA Vitality points/coins, where applicable, have been awarded.
16. In the event any winner is disqualified from the Event, AIA at its sole discretion may decide whether a replacement winner should be selected. In this event, any further winner will be selected on the same criteria as the original winner and will be subject to these T&Cs.

## Data Privacy

17. This Event is organized by Fitness First and all Participants are providing information and personal data to Fitness First directly (and not to AIA) when filling up the relevant form on Fitness First's website and making the Nominal Payment for the Event.
18. By participating in the Event, each Participant consents to:
  - (a) the collection, use, disclosure and disclosure of his/her personal data by his/her Team Leader to AIA and Fitness First for the purpose of making payment and registering for the Event ("**Purpose**"); and
  - (b) AIA's collection, use, disclosure and retention of the information disclosed by the Team Leader and the Participant for the Purpose and other Event-related purposes, in accordance with AIA Personal Data Policy (Singapore), available at: <https://www.aia.com.sg/en/index/personal-data-policy.html>; and
  - (c) Fitness First's collection, use, disclosure and retention of his/her information disclosed by the Team Leader and the Participant for the Purpose and other Event-related purposes, in accordance with Fitness First's Privacy Policy, available at: <https://www.fitnessfirst.com.sg/privacy-policy>.



19. Participants may withdraw one or more consents provided to AIA hereunder at any time via AIA Customer Care Hotline at 1800-248-8000, My AIA SG (for AIA policyholders) or by completing and submitting the relevant forms. For the avoidance of doubt, the consent provided by each Participant to AIA for the Event is in addition to any prior consent which may have been provided to AIA in relation to the use of Participant's personal data

#### **Ownership and Rights**

20. By participating in the Event, each Participant hereby agrees and authorizes AIA, to use at its discretion, without further compensation, fee, charge or other remuneration to him/her, and to disclose his/her name, addresses, personal details, photographs, videos or any likeness of him/her for packaging, promotional, advertising, marketing and/or publicity purposes (where not prohibited by written law), and to use statements or any creative content made by or attributed to him/her as winners of this Event (if applicable), and any rights in connection therewith. The Participant shall not own any intellectual property rights (including moral rights) to any of his/her work or creations submitted in connection with the Event and accordingly agrees to unconditionally waive all such rights.
21. By participating in the Event, each Participant agrees if he/she wins, that AIA may use his/her name, likeness, and/or voice in any publicity or advertising relating to the Event or future events without compensation or approval (except where prohibited by law).

#### **General**

22. AIA has the absolute discretion and right to disqualify any Participant if the corresponding registration form contains false or inaccurate information of the Participant.
23. Each Participant is solely responsible for ensuring that participating in the Event is not illegal or prohibited by the laws or regulations of any country relevant or applicable to such Participant.
24. AIA reserves the right to disqualify an otherwise eligible person from participating in the Event, or receiving any items given under the Event if AIA in its absolute discretion believes that such person may have contravened, will contravene or has contravened any of these T&Cs and/or may bring AIA into disrepute. In the event such item has already been given to such a person, the item must be returned to AIA at such person's cost and expense. Participants are deemed to have accepted and agreed to be bound by these T&Cs upon registering for the Event. AIA reserves the right to refuse entry, or refuse to award any items given under the Event, to anyone in breach of these T&Cs.

AIA reserves the right in its sole and absolute discretion to replace any item given under the Event with another item of similar value or withdraw this Event without having to give any person any notice or reason. AIA's decision on all matters relating to this Event (including the interpretation of these T&Cs) will be final and binding on all persons and no appeals will be entertained.
26. Any item given or provided under this Event by AIA or any third party is non-transferable, non-exchangeable for cash or other items and may be subject to availability. AIA is not obliged to replace any damaged, lost or defaced items. All items given or provided under this Event will be given or provided on an "as is" basis, and all warranties, express or implied, are disclaimed. Where an item contains specific date(s) during which the item should be utilized, no requests for extensions or replacements whatsoever will be entertained. AIA do not guarantee nor bear liability regarding the quality, performance, technical specifications, conditions or safety of any item given or provided under this Event. Such item may be subject to additional terms and conditions, and participants agree to comply with all terms and conditions applicable to the item given under the Event. In the event any item incurs any tax liability, such tax is the sole responsibility of the Participant.

Notwithstanding anything herein, AIA shall not at any time be responsible or held liable for any loss, injury, damage or harm suffered by or in connection with the item(s) given or provided under this Event, or the products and/or services provided by third parties under this Event.
28. Any trademarks, graphic symbols, logos or intellectual property contained in any materials used in connection with this Event, in particular that relating to the items given under the Event, are the property of their respective owners. AIA and its affiliates and contractors are not affiliated with, or endorsed or sponsored by, such owners and their relevant affiliates.
29. AIA accepts no responsibility for any registration not successfully completed due to any reason whatsoever, including but not limited to a technical fault or malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
30. AIA is not responsible for any problems with or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any entry or run data to be received on account of technical problems or traffic congestion on the Internet or at any website, human errors of any kind, or any combination thereof, including any injury or damage to participants' or any other persons' computers related to or resulting from participation in, uploading or downloading of any materials related to this Event.
31. Each Participant of this Event exempts AIA from any liability arising from any act, omission or default in connection with the use and operation of the operating platforms for the Event over which AIA has no control.
32. To the fullest extent permitted by applicable laws, AIA, on behalf of its directors, officers, employees, suppliers, licensors, and service providers, excludes and disclaims liability for any losses and expenses of whatever nature and howsoever arising including, without limitation, any and all direct and indirect loss, liability, costs and/or damage in respect of any matter howsoever arising (whether in tort, negligence or otherwise) under and in connection with the Event, including loss of profit, loss of business, loss of use, loss of data, economical loss, general, special, punitive, incidental, direct and indirect and consequential damages.
33. Each Participant taking part in the Event shall fully indemnify and hold harmless AIA, each of their respective divisions, affiliates, subsidiaries, parent, directors, officers, employees and agents, and all others associated with the development and execution of this Event (collectively, the "**Indemnified Parties**") from any and all claims, damages, losses, demands, causes of action, proceedings, expenses (including without limitation reasonable attorneys' fees), and/or liabilities resulting or arising from or connected with, or claimed to have arisen, resulted from or be connected with: (i) the participant's submission, participation, attempt to participate, or inability to participate, in the Event; (ii) submission and/or use by the Indemnified Parties of any submission (and/or any parts thereof); (iii) the participant's failure to comply with any one or more of these T&Cs or any applicable laws, rules or regulations; (iv) the unauthorized use by the participant of, as applicable, the name, likeness, voice, work product, brand, trademark, logo of any person or entity; (v) the breach or alleged breach of any warranty, representation (including, without limitation any eligibility related representation) or covenant made by the participant in connection with the Event (vi) acceptance and/or use of any items, prize or rewards awarded under the Event, if any; (vii) any right or benefit granted by the participant to AIA in connection with the Event; and/or (viii) the participant's negligence, wilful misconduct, violation of any applicable laws, rules or regulations or these T&Cs, or his or her violation of any third party's intellectual property, privacy, publicity or other right.



34. If any provision of these T&Cs is held to be invalid or unenforceable, then such provision shall (so far as it is invalid or unenforceable) be given no effect and shall be deemed not to be included in these T&Cs without invalidating any of the remaining provisions of these T&Cs.
35. No failure or delay by AIA in exercising any right or remedy provided by law under or pursuant to these T&Cs shall impair such right or remedy or operate or be construed as a waiver or variation of it or preclude our exercise at any subsequent time and no single or partial exercise of any such right or remedy shall preclude any other or further exercise of it or the exercise of any other right or remedy. AIA's rights and remedies under or pursuant to these T&Cs are cumulative, may be exercised as often as we consider appropriate and are in addition to AIA's rights and remedies under general law.
36. These T&Cs and the relationship between you and AIA shall be governed by, and interpreted in accordance with, the laws of Singapore. In respect of any legal action or proceedings arising out of or in connection with these T&Cs, you shall irrevocably submit to the jurisdiction of the courts of Singapore. That submission shall not affect the right of AIA to institute proceedings in any other jurisdiction.
37. You, the Participant, agree to be bound by and comply with the T&Cs. AIA may, at any time, in its sole discretion and without prior notice or liability to the Participant or any person, vary, modify and/or amend these T&Cs. Please review these T&Cs periodically for changes and updates. To determine when these T&Cs were last revised, please refer to the "Last Revision Date" stated at the end of these T&Cs.
